## 1. Introduction

Our website, <u>https://naturemedies.co.uk</u> (hereinafter: "the website") uses cookies and other related technologies (for convenience all technologies are referred to as "cookies"). ## 2. What are cookies?

### 5.1 Technical or functional cookies
